Constitutional Amendment

Shall the following be adopted?

§21. Right of public to hunt, fish and trap wildlife. The people have the right to hunt, fish, and trap, including by the use of traditional methods, subject to reasonable laws and regulations that promote wildlife conservation and management and that preserve the future of hunting and fishing.


Public hunting and fishing shall be a preferred means of managing and controlling wildlife.

This section shall not be construed to modify any provision of law relating to trespass, property rights or water resources.
